4. THE GROUP CAPTAIN WILL BE RESPONSIBLE FOR COLLECTION OF PAYMENTS. WE REQUEST PAYMENTS MADE FROM 1 PERSON OF THE GROUP ONLY. WAIVERS ,MUST BE SIGNED AND SUBMITTED PRIOR TO STARTING.
